Dr Medou is founder and CEO of Kandas Capital SA, an investment management company that specializes in developing and systematically implementing alternative investment strategies based on a quantitative approach to financial markets.

The research and due diligence process also benefits from the experience and analytical skills of **Mr Thierry Rambosson** the COO of Peak Partners, and voting member of the Investment Committee, who oversees the operational due diligence analysis of the administration and operational systems of the invested funds. Similarly **Mr Clive Lang**, the Chief Risk Officer at Peak Partners conducts the research into the risk management and controls of the invested funds.
